- ✓ Stay inside

- ✓ Collect all non-perishable
foods, blankets, heaters, and
potential water buckets
- ✓ Stay near your other lab
members
- ✓ Follow the Crisis Management
Team's instructions
- ✓ Read the Blizzard Crisis
Management Plan for the
University of Minnesota
Laboratories

DON'Ts

- ✗ Go outside for long periods of
time, you will risk frostbite or
hyperthermia
- ✗ Use generators inside
- ✗ Leave your lab members
without authorization
- ✗ Fear monger with other
faculty. Stay strong and help to
keep every one calm.
- ✗ Evacuate without express
approval from the Crisis
Management Team

How to Know If I Should Evacuate During a Blizzard?

Use <https://www.weather.gov/mpx/hazards> to check the status of the blizzard.

If the blizzard is marked as being in the **OUTLOOK** or **WATCH** phase and will not arrive for 2 or more hours

OR

If your environment is potentially unsafe, such as having significant structural damage or fire risk.

EVACUATE

1 Shut Down The Laboratory

 Turn off all laboratory equipment and electronics.

Blizzards can cause sudden shut off of power or flooding, which can damage equipment if left on.

 Properly store all lab chemicals.

Chemicals left in the open may cause fires, accidents, or product loss when left unattended.

2 Pack Personal Belongings



Take any personal effects from your office, locker, or lab- The best Items to pack are:

- Perishables
- Sentimental items
- Electronics

Blizzards can cause road shutdowns. Anything left behind at the facility will be unreachable during that time.

3 Inform Your Supervisor

 **Inform your supervisor, lab manager and a member of the Crisis Management team that you are leaving the building**

During shelter-in-place, headcounts will occur to make sure no staff member is missing. It is important to let a manager know of your departure so they know you are not present.



Prepare for the Road



Make sure that your transportation is still available.

Some public transportation modes or routes shut down in advance of a blizzard. It is important to know this information before you arrive at the bus stop or attempt to drive home.



Leave the building quickly and calmly.

Make sure to be fast and keep calm when leaving the building and parking lot to prevent traffic congestion.
